Pandiscio, from Susan Sullivan and Kelley Gangi (attachment 1); WRSD Governmental Funds, Fiduciary Funds Cash & Fund Balances Report (attachment 2); WRSD FY12 Budget (attachment 3); July 23, 2012 email correspondence from the Superintendent to the School Committee (attachment 4); draft public statement (attachment 5). The Superintendent stated the reasons for the executive session are to consider the discipline of an employee, the recently found FY12 budget deficit, and the leadership of the District, the Superintendent. Superintendent Pandiscio distributed his July 23, 2012 confidential memorandum to the School Committee (attachment 6). Chair Leith reminded members that documents reviewed in executive session and discussions that take place in executive session are confidential and should kept confidential until the matter is settled. Members were asked to read the prepared draft public statement (attachment 5), a statement that will be read aloud at the public session. The draft public statement was discussed and edited.

Motion: Chair Leith will read aloud the following statement, in public session to follow the executive session:

This evening in executive session the Wachusett Regional School District Committee voted to terminate the contract of Peter Brennan, its Business Manager. Mr. Brennan was dismissed for failure to perform his duties as the District's chief financial officer in a satisfactory manner. Specifically, Mr. Brennan failed to forecast growth in the health insurance budget in an adequate manner. He ignored the District's standard practice of using spending history to predict future expense and instead relied on the previous year's budget to make his prediction. The result is that the District will be forced to make significant cuts in other line items in order to account for this shortfall and balance its budget. These reductions will be proposed this evening.

More recently Mr. Brennan left the FY12 budget out of balance by utilizing a faulty spreadsheet of his creation to guide District spending. It is clear that a costly error for which Mr. Brennan is responsible occurred. Currently District staff is working to address this issue so that the budget can be brought into balance. Member
