Interim Superintendent Gasbarro updated the School Committee on the status of reviewing math curriculum. Four "sample" are being reviewed by the Math Leadership Team, a group that continues to meet on a regular basis.

Interim Superintendent had shared a video about the December 12, 2013 "Wreathes Across America" event at Thomas Prince School. He spoke about the stop made in Princeton and highly commended TPS Principal Mary Cringan and the entire TPS community for hosting this event.

Interim Superintendent Gasbarro reported that the District will be participating in PARCC assessment testing this year. At Glenwood Elementary School all students will take part in the end-of-year online assessment. Glenwood Principal Dennis and the DESE are in communication to iron out the details for the school's participation. Interim Superintendent Gasbarro told the Committee that since the PARCC testing is a pilot program, no results will be distributed to schools or parents.
